YFA REPRESENTATIVE COUNCIL Minutes DATE 03/19/2025

Called to Order: 3:05 pm Consent Agenda:

- Approve Rep. Council meeting minutes February 19th, 2025*- Mike Adams motioned to approve; and Scott Taylor 2nd the motion. Motion carried unanimously.
- Recognize 2025 -2026 election results* Congratulations to everyone serving in YFA!

Action/Discussion/Continuing Projects

- Guest: YCCD District Trustee, Area 6- Leslie Beggs
 - O Guest Trustee Leslie Beggs- Brian gave a brief introduction of Trustee Beggs. Brian felt that it was important for YFA Reps to recognize that the Board is made up of individuals who have shared experiences like them. Therefore, he wanted to introduce the Reps to Trustee Beggs. Trustee Beggs discussed her family history of attending MJC, and her personal educational journey. She discussed her journey of becoming an educator, published writer, and finally a Trustee Member. In addition, she is one of 2 trustees that has been a faculty member at MJC. Brian and Trustee Beggs had a jovial conversation about her experiences on the Board and how her experiences as a faculty member inform her decision making, as well as sharing her experiences with other board members. Brian masterfully directed their discussion to invite Trustee Beggs to share her philosophy of being an effective Trustee member. A small discussion about CCAP followed.
- Investing Reserves Brian Greene
 - O Update- In the last Rep Council meeting, the Reps were asked to discuss the idea of possibly investing a small portion of the YFA Reserves, and the Reps shared that many people wanted more information from us, so Op, Hardev, and I consulted with different financial advisors about the current financial climate. However, in our last Exec meeting, we had a robust discussion, and there was an agreement to stop this idea of investing in YFA Reserves for the time being. Brian stated that he was willing to share the financial information that he, Op, and Hardev collected with anyone who wants it. No action was necessary.
- Binding Arbitration vs. Advisory Arbitration Derrick Wydick
 - O Brian explained the difference between a grievance and a complaint. A grievance would address faculty / Dean issues that are not in alignment with the contract. For example, Article 4.5.2 states that unless a faculty member voluntarily chooses to exceed 4 preparations, no faculty member can be assigned more than 4 preparations during a semester. However, if a faculty member has been assigned 5 preps, that faculty member could ask YFA to file a grievance on his or her behalf. If a faculty member is harassed or abused in any way, then a complaint would be filed on behalf of the faculty member. Brian then briefly reviewed the 3 levels of the grievance process and the timelines of each level. We have Advisory Arbitration in our contract, which means the decision is not binding on the district and could be ignored. He also discussed the expense of using Arbitrators. Mike Adams stated that Binding Arbitration can be dangerous because it does not have all the safeguards of a lawsuit, but because it binding, you are stuck. A small discussion followed.
- 2025 2026 Exec. & Rep. Council meetings Brian Greene Erin Black motioned to adopt the 2025/2026
 Calendar; Iris Carroll 2nd the motion. The motion was unanimously approved.

Announcements and Updates

- President's Report Brian Greene
 - Elections- Faculty Liaison Position is currently open now. The nomination window closes on Friday, 3/21/2025. There are 2 candidates who have submitted their intent to run for this position. It is the Rep Council that votes. We have one more meeting this year, and we will vote during that session. We will need quorum for that meeting. We will have a special election for

- Optimisms position. He is the new YFA President Elect, and his VP position is open, and it will close on Friday. The Rep Council will vote for that position too. Right now, there is only one person that has submitted an intent for that position.
- The West Campus YFA Space, Yosemite 205, has gone through all of the initial stages and is awaiting confirmation before it can be final. Next, we will have to make some updates to the space. It looks like it is going to work. A lot of faculty groups on west campus will be able to use that space. A small discussion followed.
- Trivia Night-Faculty Trivia Night will be on 3/20 at the Contentment Brewing Company, across the street from Founders Hall, and YFA is sponsoring the dinner. Beer will be available for purchase. Non-alcoholic beverages provided by the MJC Academic Senate.
- Brian thanked Erin and Brandon for putting this event together.
- o Brian shared Faculty Service Areas (FSAs), are the disciplines that all full-time faculty are assigned when they're hired. They only apply if there are layoffs as they are intended to facilitate the bumping process. Faculty can apply for additional FSA once a year, in October. You have an opportunity to apply for an FSA if you qualify for one. FSAs are separate from the equivalency process, although faculty must meet minimum qualification or equivalency to qualify for an FSA. YFA is working with HR to confirm the current seniority and FSA list is correct. Watch for an email from YFA to confirm that your date of hire and your FSA are correct. A small discussion followed.
- Vice Presidents' Reports
 - Optimism One Absent due to Family emergency
 - O Derrick Wydick- Gave a brief report of his cases.
- Negotiations Update Shelley Akiona Traub -
 - O The first negotiation session of the semester was February 28. We met again on March 14 when the District finally brought forward a proposal to address MJC's RSI compliance requirement from ACCJC. The district is essentially asking us to give away some of our academic freedom to meet the new requirements. Due to RSI Compliance issues, many changes in the evaluation process are being considered. We may have to adopt some of these very prescriptive things to meet the new standards. Another topic will be off-cycle evaluations. In addition, some faculty may want to opt out of teaching online to avoid this cycle of evaluations. A robust discussion followed.
- Treasurer's Update Hardev Dhillon- Hardev gave a brief account of our finances.

- Faculty Liaison Update Allan McKissick -
